## ORDER NO.H2/35920/11 DATED: 18.05.2012

Government as per Order read as 1st paper above have approved a comprehensive package in principle for introducing a scientific method for appointment and deployment of teachers in aided schools. Accordingly the list of teachers who were not getting salary for various reasons have been collected from the Deputy Director of Education and the same has been published as appendix I of the G.O. read 2nd paper above. In the direction to approve their appointments without waiting for appellate orders after ensuring that they were appointed against regular vacancies and qualified to hold the posts.

In the meantime certain complaints have been noticed that same deserving cases have not been included in the list and some ineligible teachers are included by mistake. Hence a number of cases included in appendix I of G.O. read as 2<sup>nd</sup> paper have been excluded for further verification. Accordingly as per order read as 3<sup>rd</sup> paper above the teachers whose names were included in appendix I of G.O. read as 2<sup>nd</sup> paper above and who were subsequently excluded for want of genuineness of their qualifications, court cases, management disputes, established vacancy etc. were allowed to register their complaint in the prescribed proforma on online and Shri.C.Varghese Super Check Officer, Super Check Cell, Kozhikode was assigned with the work of sorting out of complaints of Teachers related to the implementation of Teachers Package.

Accordingly the Super Check Officer, Super Check Cell Kozhikode has conducted hearing with affected parties and concerned Educational Officers and furnished the list of Teachers who were eligible to be included in the Teachers Package as per 5th Paper read above.

Government as per order read as 6th paper above have accorded sanction to include the 40 teachers in the teachers working without salary. In the above circumstances the appointment in respect of the following teachers are accepted for approval w.e.f. 1.6.2011 in terms of Government Orders read as 1st 2nd and 3rd paper read above.

The appointment of substitutes appointed in the place of claimants as per Rule 43 of Chapter XIV A KER or seniors, and whose names are included in the list shall be approved and paid salary after approving the appointment of 43 Claimants and senior hand. The District Educational Officers/Assistant Educational Officers will ensure that there is sanctioned post to accommodate the teacher and issue final approval of

appointment orders in each individual case within 7 days from the date of receipt of this order and report to the undersigned by return.

The teachers will be paid pay and allowances from 1.6.2011 onwards. The approval given by the Educational Officers will be subjected to further scrutiny by officers authorized by the undersigned. The Educational Officers shall be held responsible for any discrepancies detected later and the loss sustained to Government shall be got realized from them.
