- 1. HSSTs were included in the select list approved by the Departmental Promotion Committee held on 29-03-2010. But they were not promoted/ relieved as HM/AEO based on the decision in Government letter No. 12970/C2/2010/G. Edn, dated 07-04-2010. The 25 HSSTs were again included in the select list approved by the Departmental Promotion Committee held on 12-05-2011 in the light of Government letter No. 38048/C2/10/G. Edn dated 03-09-2010 and based on the judgment dated 14-03-2011 in WA No.2070/2010. Government decided to continue the same method adopted in previous years in the promotion aspects to HSSTs selected from among HSAs by transfer.
- 2. in this regard, Sri. Brahmasuthan, HM/Principal and Dr. A K Appukuttan, AEO Changanassery filed WP(C) No. 31262/11 before the Honorable High Court to include their names in preference to their juniors in the seniority list. The Honorable High Court in its judgment read above directed Government to take a decision on Exts.P7 and P7(a), with notice to the petitioners and any other affected parties, within a period of six months from the date of receipt of a copy of the judgment.
- 3. On the basis of the judgment Government heard the petitioners on 07-02-2012 and decided to submit the select list of the 25 HSSTs for retrospective promotion before the Departmental Promotion Committee (Lower) on 27-03-2012. Since there was no dispute about the inclusion of their names in the select list, the committee decided to take up this case with Government by the appropriate authority.

If these teachers were considered for promotion to the post of HM/AEO according to their seniority, they would have been promoted in the cadre of HM/AEO much earlier than the actual date of promotion. Considering the above facts Government have accorded sanction to promote the 25 HSSTs retrospectively.

In the above circumstances, following HSSTs are notionally promoted from the date shown against their names and their names included in preference to their juniors in the seniority list. Orders fixing the new rank in HM/AEO cadre will be issued separately.
